If you experience this discoloration of water, please run your cold water in a basement sink for 15 – 20 minutes. This should clear your problem. Please make sure during this flushing period that you check your cold water for discoloration. If the water is discolored, please flush your line as mentioned above before attempting to do any laundry.

Our workers will carry out this task between 7:30 a.m. and 4:00 p.m. Our workers have company identification cards for your security.
